A. Who Cares?

In mid 2009, on one of the many blogs devoted to academia, a law professor posted an account of a paper he had given to a faculty workshop. Afterward, he fielded questions from colleagues, one of whom surprised him with the simple question, "Who cares?" It was not, he assured his readers, asked sarcastically. It forced him to reexamine and discuss the purpose of writing articles on esoteric subjects of great interest to a few fellow scholars, but with little popular appeal. The ensuing debate led me to ask the same question about the Minnesota Legal History Project. The answer I knew immediately: Not many.

A website such as the MLHP can be justified on several grounds. Foremost: Any endeavor that increases our knowledge of the law is worth the effort. It may encourage future research and writings on the state's legal past (less than ten top notch articles have been written on the subject so far). The articles posted here also serve a utilitarian purpose in that they satisfy our curiosity, as does, though on a grander scale, a biography of Napoleon or a history of Pompeii. And a few articles recall and resurrect individuals—usually lawyers or judges—who have been forgotten.

B. Statistics

The MLHP, like other websites, has a function that keeps statistics of its viewers—where they are located, what articles are most popular, and so on. For an educational website like the MLHP, the number of "viewers" is more important than the number of "hits" which is valuable to commercial users of the internet. However, the gross number of "viewers" is misleading because it includes each time search engines (now called web robots or "bots") such as

Yahoo, Google or Microsoft which sweep the internet for new postings, and in the process "view" the MLHP. This happens several times a day, resulting in an inflated number of "viewers." I estimate that over 50% of the "viewers" of the MLHP are bots, not real people. Because most bots are located in California, or Colorado where Qwest is situated, exceptionally large numbers of "viewers" in those states are recorded. Table I lists visitors at the beginning of each month for 2009.

The statistics maintained for the MLHP are for a thirty day period. The following tables cover two 30 day periods, which can be compared:

Table II covers May 31 to June 30, 2009. Table III covers November 28 to December 27, 2009.

^{* &}quot;Unique IPs" stands for Internet Protocol. It is an "address" for a computer or network of computers, like the physical address for a building or an apartment. Often times, in an area where there are multiple PC's there may only be one IP address (EX: a library may have 20 computers, but only one IP address for the building). This column lists the number of unique IP addresses that have accessed the MLHP website. This function is designed to separate IP addresses from PC's.
