Twenty-four lawyers and one law firm were named as practicing in Minnesota Territory in the 1851 edition of *Livingston's Law Register*. Seventeen practiced in St. Paul, five in Stillwater and two in "St. Anthony's Fall." The last names of Henry L. Moss and Ellis G. Whitall were misspelled. The first names of Henry F. Masterson and Orlando Simons were omitted.

Isaac Atwater arrived in Minnesota Territory in 1850 but was not listed. The three territorial justices were not named. There may be a few others.

It was a small bar, concentrated in three villages, each situated on a river. It would get bigger. ■
