TERMS FOR COLLECTING

—AND—

PROFESSIONAL FEES.

Debts originally reported uncollectible will be subject to no charge beyond the expense of correspondence, unless at the client's request extraordinary trouble is taken or suit is brought, when terms will be agreed upon.

On collections made by negotiation, *repeated demand* or ordinary process of law, where no defense is made, 10 per cent. will be charged on the first \$300; 5 per cent. on its excess to \$1000, and 2½ per cent. off the excess of \$1000.

Where *suit is brought*, or an important opinion given, the *fee* will be the same as the attorney in the respective cases usually charge their local clients for like services.

No fee or commission of less than *three* dollars will be charged in any case, except by special arrangement. Minimum fee for suit, \$5.

Cases *settled by clients*, after having been placed in counsel's hands, will be subject to the same charges as if settled by the latter.

The above rates do not apply when the rules of the Bar where business is sent prescribe other terms. In *such* cases these rules will govern, as *trustworthy attorneys cannot be otherwise obtained*.

In exceptional cases special terms will be made.

When business is received from a correspondent, the attorney receiving and transacting it, *will retain two-thirds of the fees* or commissions, and remit one-third to the party sending it.

No expense will be incurred *without instructions*, except in case where the client's interest will suffer by delay.

Clients ordering suit will be liable for all Court costs.

Clients putting claims in judgment to prevent the bar of the statute or the like, will be subject only to such charges as may be agreed upon.
